It is hereby also understood that no helmet or protective equipment can protect against all foreseeable injury.
- I hereby certify that every horse and rider is eligible as entered and agree for myself and my representatives to be bound by the Constitution and Rules of Equine Canada and the Edmonton Classic Prize List.
- I certify that I am fully capable of participating in competition, schooling and normal use of a horse. I assume and accept full responsibility for bodily injury, death, or loss of personal property and expenses as a result of those inherent risks, dangers and hazards identified herein, and those inherent risks, dangers and hazards not specifically identified herein.
- In consideration of being allowed to participate in this event, I hereby irrevocably release and forever discharge Amberlea Meadows Equestrian Center and EHJA, their owners, employees, directors, shareholders, agents, representatives, volunteers, and sub-contractors, specifically from all liability, claims, demands, damages, actions or causes of action arising or as might arise, present or future, whether known or unknown and whether in law or equity, in connection with or arising from my participation in the Edmonton Classic Horse Show, including but not limited to bodily injury to myself or my horse(s) and damage to property arising from any cause whatsoever, including, but not limited to, the negligence of one or more of the individuals or organizations referred to herein.
